

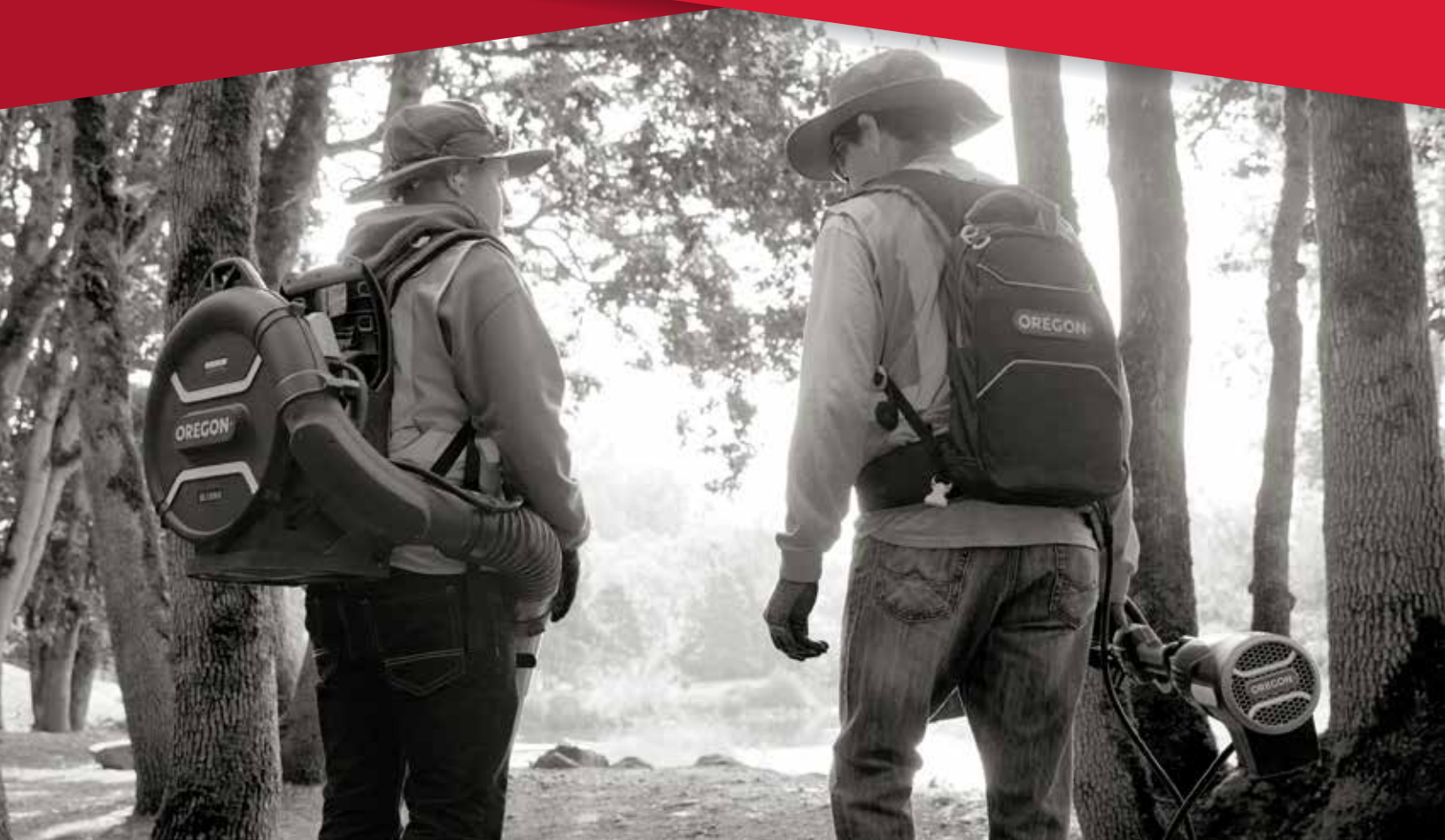

## Program Details

The South Coast Air Quality Management District has authorized grant funding to be used to reduce the purchase price of commercial electric lawn and garden equipment.

The participants (local governments, school districts, nonprofit organizations and commercial gardeners) operating in the South Coast Air Quality Management District will have the opportunity to select from a variety of qualifying makes and models of commercial grade electric lawn and garden equipment.

## How it Works

At Authorized Dealers, qualifying participants will exchange older commercial gasoline lawn and garden equipment and receive an immediate discount toward the purchase of like-kind electric commercial-grade equipment (e.g. a blower for a blower). The gasoline lawn and garden equipment will be tested for operation, surrendered at the Authorized Dealer, drained of all fluids in a responsible manner, and then taken to a licensed dismantler where the equipment will be permanently destroyed.
